<u>The below is for CONSIDERATION ONLY</u>, we are attempting to be proactive and place procedures in place <u>PRIOR</u> to any reduction of the current restrictions in place. We request the Board review the below information and consider for distribution to the residents.

In anticipation of the relaxing of the Covid-19 restrictions currently in place by Governor Cuomo, we are discussing plans for properties and policies to be in place for the following:

## PPP LOAN:

Please be aware that there is new hope that the PPP Loan/grants may still be extended to cooperatives. In the bill passed by Congress on May 15, 2020, there is a provision for \$100m for Cooperative assistance. We are doing preparations in our office for this possibility and will correspond separately with each effected property in the future if this becomes law. This latest economic assistance plan currently still needs to be ratified by the Senate and the President.

## MOVE IN/OUT:

Only one move will be permitted per day. This move MUST be schedule 2 weeks in advance and approved by management prior to be scheduled. If possible, a one elevator will be assigned for use by the movers and only basement/service entrance access will be permitted.

## • RENOVATIONS:

Any renovation that was stopped due to the health crisis will be allowed to start. When those are completed, any new request will then be scheduled accordingly. (following approval procedures currently in place). NOTE: All Contractors must have a NYS safety plan prior to any work.
